- In email and other inquires to OGC that are sent in response to our Sites.

It does not apply to information collected by:

- Us offline or through any other means, including information collected if we agree to represent you;
- From job or network attorney applicants; or
- Any third party, including through any links to or accessible from our Sites.

Please read this notice carefully to understand our practices regarding your personal information. By accessing or using our Sites, you agree to this privacy notice. #### Information We Collect and How we Collect It

We collect information from and about users of our Sites, including:

• Information by which you may be personally identified, such as name, address, e-mail address, telephone number, or any other identifier by which you may be contacted online or offline; and

• Information automatically collected about your usage of our Sites that may or may not personally identify you (and may be combined with information that does personally identify you), including usage details, IP addresses, and information collected through cookies and other tracking technologies.

We collect this information in two ways:

- Directly from you when you provide it to us, such as your direct inquiries in response to the information provided on our Sites, and records and copies of your correspondence with us.
- Automatically as you navigate through our Sites.

### **Information We Automatically Collect**

We may use automatic data collection technologies to collect information as you interact with our Website about your equipment, browsing actions, and patterns, including:

- Log Data and Device Information. Details of your visits to our Sites and the resources that you access and use on our Website, including traffic data, location data, logs, and other communication data, internet connection or mobile network, IP address, hardware, operating system, device identifiers, and browser type.
